MILESTONE	DATE
ACSP registration opens	18 March 2025
Voluntary ID verification begins	8 April 2025
Mandatory IDV for new confirmations and incorporations	18 November 2025
Filing on behalf of others requires ACSP	Spring 2026 (TBC)

We do not want to create unnecessary duplication or miss out on using existing processes.





#### Workflow for CH and AML requirements





## Comparing CH direct vs ACSP

CH Direct	ACSP
Fully outsourced - no risk or cost of IDVT	Easier to track customer progress and incorporate into firm workflows
Limitation of GOV.UK One Login might result in diverting to post office verification	Supporting customers who cannot navigate Companies House or GOV.UK One Login app
Personal number automatically stored in GOV.UK One Login account	Reduce bottle necks and delays by using existing identities and documents - reduce duplication of IDV



# ACSP Route - 2 Options



## Options for IDV - ACSP route

ACSP Option 1	ACSP Option 2
Mirrors CH Direct route	ACSP facilitates IDV through a flexible combination of document and technology based solutions
No human judgement allowed - relies 100% on technology	Human judgement and training combined with support from IDVT

## CH and Option 1 pitfalls


Pitfalls	Description	
Documents	Requires Passports with cryptographic features (electronic chip) or UK driving licence (other documents too - but the list is limited)	
Technology	IDVT technology does not have a 100% pass rate. Various reasons, could cause a result that is not a definitive pass.	
Accessibility	Whether it is a disability, unfamiliarity with technology or restrictions on app installations on a device, there are various reason CH or Option 1 might not be accessible to all	

You process is only as strong as the weakest link



## Flexible IDV using Option 1 and 2

#### USING ONBOARDING REQUESTS TO INITIATE ID VERIFICATION - MEETING COMPANIES HOUSE STANDARD



- Option 1 relies entirely on IDVT (Identity Document Validation Technology), with little or no manual intervention or review required.
  Option 2 provides an alternative route, typically used for a wider range of identity documents or in cases where IDVT technology has not been able to reach a definitive conclusion based on the images and cryptographic features provided.
- It is also important to note that while Option 1, if successful, meets the Companies House standard, parts of Option 2—such as verifying address information through a proof of address document or via an electronic ID (eID/AML) check—may still be required to meet the threshold for AML compliance.





## Final thought on Option 2

If you prepare your firm to use Option 2 as a viable backup to CH Direct and Option 1...

## Option 2 training requirement

#### Step 3: Check the evidence is real

If the evidence is being checked by a person, they must be trained in detecting false documents and be familiar with the <u>guidance on examining</u> <u>identity documents to detect basic forgeries</u>. Companies House cannot recommend any specific training providers but they must follow the Home Office best practice guide.
